16. Downtown Special Event Fee Waiver Request - Campbell Chamber of Commerce

Recommended Action: That the City Council consider and provide direction to staff regarding the requests from the Campbell Chamber of Commerce to (1) approve a fee waiver allowing the Campbell Chamber of Commerce to pay no more than \$25,000 in Downtown Special Event Permit fees to the City of Campbell for processing and staffing costs related to the Campbell Chamber of Commerce's 2023 Boogie Music Festival; and (2) amend the existing Promissory Note between the City of Campbell and the Campbell Chamber of Commerce to reflect the same not-to-exceed Downtown Special Event Permit fee amount of \$25,000 for the Campbell Chamber of Commerce's Boogie Music Festival and Oktoberfest events held in 2019, 2021 and 2022.

Assistant City Manager Gaeta presented a staff report dated May 2, 2023.

Following Council questions, Mayor Bybee asked if anyone from the public wished to speak.

Campbell Chamber of Commerce Executive Director, Ken Johnson spoke of the community benefit to the Chamber events, presented a history of past events in relation to costs, fees, and revenues. He requested the City Council amend the existing Promissory Note between the City of Campbell and the Campbell Chamber of Commerce to reflect the same not-to-exceed Downtown Special Event Permit fee amount of \$25,000 for the Campbell Chamber of Commerce's Boogie Music Festival and Oktoberfest events held in 2019, 2021 and 2022.

Nicholas Welzenbach, of Darling & Fischer Garden Chapel and Chamber of Commerce member spoke in support of the Chamber and their request.

The Council discussed the fee waiver request and amending the existing promissory note to reduce the fees owed and how it relates to the City's fiscal responsibility.

Police Chief Berg provided information related to the Police services that are needed to staff the Chamber events and the costs thereof.

There was Council consensus to approve the \$25,000 fee waiver for the Chamber's 2023 Boogie Music Festival.

After discussion, M/S: Furtado/Scozzola – That the City Council consider and provide direction to staff regarding the requests from the Campbell Chamber of Commerce to approve a fee waiver allowing the Campbell Chamber of Commerce to pay no more than \$25,000 in Downtown Special Event Permit fees to the City of Campbell for processing and staffing costs related to the Campbell Chamber of Commerce's 2023 Boogie Music Festival. The motion was adopted by the following roll call vote:
