First Street, Campbell, California, as the time and place for a Public Hearing to consider placing the cost of abating hazardous vegetation on the property tax assessment roll.

Assessments and other supporting documentation are on file and available for public review in the Community Development Department, 70 N. First Street, Campbell, California. Interested persons may participate in this meeting and/or provide written comments on these assessments that may be submitted before that date. Please be advised that if you challenge the nature of the above project in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this notice, or in written correspondence delivered to the City of Campbell City Council prior to the Public Hearing. While members of the public will not be able to attend the meeting of the Campbell City Council physically, the meeting will be live-streamed on YouTube at (<https://www.youtube.com/user/CityofCampbell>).

This public hearing will be conducted via telecommunication and is compliant with provisions of the Brown Act and Executive Order N-29-20 issued by the Governor.

In the event that the provisions of Executive Order N-29-20 are modified or suspended before the date of the meeting so as to require physical attendance by participants, the meeting will be held in the City Council Chambers at 70 N. First Street, Campbell, California. Additional procedure will be detailed in the published meeting agenda; and any updated information will be posted to the City's website at www.campbellca.gov.
