NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City Council of the City of Campbell has set the hour of 7:30 p.m., or shortly thereafter, on **Tuesday, February 20, 2024** in the City Hall Council Chambers, at 70 N. First Street, Campbell, California, as the time and place for a public hearing to consider the request of Mike Amini on behalf of Don Barnetson to allow a subdivision from 1 lot to 2 lots and construction of an approximately 2,032 square-foot new two-story single-family residence on the newly created lot on property located at 189 Sunnyside Avenue. The application under consideration is a Planned Development Permit and Tentative Map submitted under an SB-330 preliminary application filed in compliance with Government Code § 65941.1. File No.: PLN-2023-136. Staff is recommending that this item be deemed Categorical Exempt under CEQA.

Interested persons may appear and be heard at this hearing. Please be advised that if you challenge the nature of the above in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this Notice, or in written correspondence delivered to the City Clerk at, or prior to, the Public Hearing. This public hearing will be conducted in person as well as telecommunication and is compliant with provisions of the Brown Act. The City Council meeting will be live-streamed on Channel 26, the City's website and on YouTube (<https://www.youtube.com/user/CityofCampbell>) for those who only wish to view the meeting.
