NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City Council of the City of Campbell has set the hour of 7:00 p.m., or shortly thereafter, on **Tuesday, August 20, 2024** in the City Hall Council Chambers, at 70 N. First Street, Campbell, California, as the time and place for a Public Hearing to consider an Ordinance of the City Council of the City of Campbell amending Chapter 2.08 (Officers) clarifying the role of the Community Development Director and Building Official, adding Chapter 6.13 (Air Quality) to establish NOx emissions regulations, and amending Title 18 (Building Codes and Regulations) to remove requirements related to electrification and woodburning appliances and amend the definition of scope of work of the Campbell Municipal Code. FILE NO. PLN-2022-112.

Interested persons may appear and be heard at this hearing. Please be advised that if you challenge the nature of the above in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this Notice, or in written correspondence delivered to the City Clerk at, or prior to, the Public Hearing. This public hearing will be conducted in person as well as telecommunication and is compliant with provisions of the Brown Act. The City Council meeting will be live-streamed on Channel 26, the City's website and on YouTube (<https://www.youtube.com/user/CityofCampbell>) for those who only wish to view the meeting.
