Request to remove the existing vinyl siding to expose the original wood siding beneath, repair and restore the exposed wood siding as needed, install insert-replacement windows within the existing window frames, and restore the historic front window shutters on an existing single-family residence, commonly known as the Harry Berry-Babb House.
