NOTICE OF PUBLIC HEARING

Notice is hereby given that the Planning Commission of the City of Campbell has set the time of 7:30 p.m., or shortly thereafter, on Tuesday, **May 12, 2015**, in the City Hall Council Chambers, 70 North First Street, Campbell, California, for a Public Hearing to consider the application of Farideh Zamani for a Conditional Use Permit (PLN2015-30) to allow previously completed, and proposed alterations, repair, and rehabilitation of an existing single-family residence on property located at **99 Alice Avenue** in the R-1-6(H) (Single Family Residential/Historic Overlay) Zoning District. A Mitigated Negative Declaration (PLN2015-117) has been prepared for this project.

Interested persons may appear and be heard at this hearing. Please be advised that if you challenge the nature of the above project in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this Notice, or in written correspondence delivered to the City of Campbell Planning Commission at, or prior to, the Public Hearing. Project Location Map





